The committee was requested to submit the report on physical verification of requirements as mentioned in the statute No 6 of 2015 for granting recognition as place for higher learning and Research for the Department of **Chemistry and English**.

The committee visited collage on 1st July 2021 and all the members of the committee were present during the meeting held at 11:30 a.m. in the office of the principal Nabira Mahavidyalaya, Katol district Nagpur.

Committee also visited the department of **Chemistry and English**, all laboratories of the concern subjects and library. Committee especially visited main library of the college for verification of online e-Journals and research related books and other reference books.

The members of the committee have interacted with the supervisors and others teachers of the Departments of higher learning and research center.

Committee verified all infrastructure facilities, laboratory facilities with equipment including software purchased by the college for conducting research, research publications of the research scholars and teachers and financial support from government agencies under minor or major research program during last five years.

In view of the provisions of Statute No 6 of 2015 under section 30 (2)(m), 51(2), 84(3) of Maharashtra University Act 1994 and section 114(2) of Maharashtra Public University Act, 2016 for granting the recognition for place of higher Learning and Research Centre.

The following are the observations and recommendation of the Committee:

OBSERVATIONS:-

1. The college has submitted first time for granting of recognition as a place of higher Learning and Research Centre for the Department of **Chemistry and English**.
2. The college has PG programme in the subjects: - **English and Chemistry**. The committee verified the letter of **first affiliation** granted by the University as evidence.
3. The college has recognized by 12 B and 2F as per UGC Regulation.

6. There is no collaborative research work of any the faculty of Chemistry Department with any other repute research institution/ Labs.

SUGGESTION FOR UP GRADATION:-

1. The quality and percentage of research publications should be increased in Scopus, cited and peer view International journals.
2. Research methodology, research orientation , research refresher courses are needed to be conducted
3. Industry, corporate sector, Scientific and college interaction platform rapport is needed.
4. The facilities of Higher Learning and Research center in the subject should encourage the students of registration of Ph.D. programme both in English and Chemistry.
5. Organize Seminar, Conference and Workshop, related to the research field of both the subjects.
6. Melting/ boiling point assembly (digital) is essential, FTIR Instrument, TLC Chamber and assembly, CHNS analyzer are in option in the Chemistry Department of College.


RECOMMENDATIONS:-


