# GOVERNMENT VIDARBHA INSTITUTE OF SCIENCE AND HUMANITIES, AMRAVATI

The Government Vidarbha Institute of Science and Humanities, Amravati was established in the year 1923 as King Edward College. This college was established in order to fulfil the needs of Higher Education in the region of old Central Provenance and Berar. The Education history of this college has been very glorious and splendid and its place is unique among the five districts of the region of Vidarbha i.e., Amravati, Akola, Buldhana, Yawatmal and Washim.

After Independenc King Edward College was renamed as Vidharbh Mahavidyalaya. Initially in 1920's King Edward College was an understanding college. In Arts faculty it was imparting education up to Bachelor of Arts i.e., B.A. and up to intermediate level in the Science faculty. There were only 150 students enrolled in the college. Mahavidyalaya started P.G. courses in Physics, Chemistry, Zoology and Botany. In 1962 Post Graduate Departments in English, Sanskrit, Political Science and History were started. Today the institute has the honour of having 22 Post graduate departments. The institute is also a Research Centre for Ph.D. in 20 subjects. The teachers are recruited through the Maharashtra public service commission. The institute has been awarded the prestigious 'A' grade by NAAC with CGPA 3.51.

## DEPARTMENT OF ZOOLOGY

Zoology is the branch of biology concerned with the study of animals and animal kingdom. It is also known as animal biology. The study of Zoology includes the interaction of animal kingdom in their ecosystems such as classification, habitat, structure, embryology, distribution, evolution, and extinct species. It includes diverse approaches such as electron microscopy, molecular genetics, molecular biology etc. Our goal lies to provide a comprehensive understanding in different aspects of Zoology. Department provides quality education to the student community. We have well, MPSC selected, ten teaching staff including, Professors, Associate Professors and Assistant Professors. Two specializations, Animal physiology and Molecular Biology are offered for the post graduate course. Different disciplines of zoology like Chordates, non-chordate, Animal Physiology, Molecular biology, Endocrinology, Ecology and Environment are included in the syllabus. Department every year installs a vibrant zoological society with its manifold activities pertaining to different areas of biological sciences The leadership and planning skills are tuned and perfected by conducting various competitions under the umbrella of the society. Departmental Museum is one of the prestigious museums in Vidarbha region with about 1065 animals from different phyla. Department also holds a wide array of latest as well as exotic old books in the departmental library. A total of 5119 number of books are available in the departmental library along with Volumes of Fauna of British India. Here, at the department of zoology we welcome all the aspiring students to join hands with us and get transformed through the process of knowledge.

Nabira Mahavidyalaya, Katol was established in 1961 with the help of a generous donation by Late Shri. Bhikulalji Nabira provides the facility of quality higher education to students of Katol and the adjoining area It has a beautiful and spacious campus in Katol. It aims at giving its students quality education at their doorsteps. The institution's campus is spread lush green land over an area of 6.645 acres. It has been providing quality higher education in Arts, Commerce and Science and management streams at the under graduate and post graduate levels. The institution runs total 18 UG, 07 PG and 3Certificate courses. # **DEPARTMENT OF ZOOLOGY**

The Department of Zoology at Nabira Mahavidyalaya in Katol is setting a key precedent for advancing higher education and preparing the next generation to meet the difficulties facing the rural society. The Department of Zoology was founded in 1970 and consists of three groups: Zoology, Botany, and Chemistry. It began with 32 students in the CBZ group and has grown to 240 students in the CBZ/CMZ group in 2022. Students from the department have excelled in a range of professions, including administration, politics, social work, and academia.

The department includes a functional infrastructure, including well-equipped UG and PG laboratories, faculty offices, storage areas, Animal Museum and a research lab with high-end equipment for students and research scholars.

The Department of Zoology engaged in the neurobiology research since from the 2010 and received the grant of rupees 4538901/- from UGC and DST. Neuroanatomy lab of the department helps the students to carry out their research work under the umbrella of MOU with the other institutions. Total 13 research publications are under the departmental credits. A certificate course on sericulture approved from RTM Nagpur University run by the department for the students to look in to the self-employment.

Department of zoology involved in the student's centric activity such as workshops, seminars guest lectures, exhibition, poster competitions and miniprojects to impart the scientific temperament amongst the students and to develop the research-oriented skill at the UG and PG level.

# 3. TERMINATION

Any institution may terminate the MoU by giving written notice six months in advance to the other institution. Once terminated, neither NMV nor GVISH will be responsible for any losses, financial or otherwise, which the institutions may suffer.

#### 4. AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the Heads of the Institutions of NMV and GVISH.

## 5. ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activity under this Memorandum must adhere to the law and rules and regulations of both the institutions.

## 6. LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

#### 7. DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, Principals of both the institutions will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

NMV and GVISH welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
